1. ENTRIES

- 1.1. This Event is only open to those Competitors holding a current AASA General Speed Licence or higher. To apply for or renew a 12-month AASA General Speed Licence, please visit www.aasa.com.au or contact AASA on 03 5721 7800. AASA Day Licences are also available for this Event at www.aasa.com.au.
- 1.2. Participants must be a member of an NSW Affiliated Car Club
- 1.3. The organisers reserve the right to postpone, abandon or cancel the Event.

2. ENTRY FEE

- 2.1. The entry fee is \$355
- 2.2. Payment and entry will be accepted by www.wrx.org.au/events . only.

3. INSURANCE

Personal Accident Insurance is provided under the AASA Permit. Details can be found at www.aasa.com.au.

4. DRIVER APPAREL

Drivers apparel shall be clothing which covers wrist to neck to ankle, with socks. Cotton or woollen as specified in <u>AASA Appendix 4 – Apparel Requirements</u> for Speed Events – Testing.

5. VEHICLE AND SAFETY REQUIREMENTS

- 5.1. Vehicles must comply with the AASA NCR's.
- 5.2. Vehicles must be Event ready with all loose items removed from the vehicle.

6. SCRUTINY

6.1. Scrutiny will begin at 7AM, drivers are required to attend Sign on on the lower level of the Main tower where they will be given a form to present at scrutineering in the Scrutineering Bay.



- 6.2. Vehicles entered in the Event must have passed scrutiny prior to participating in any track activities.
- 6.3. Driving apparel including helmets must be presented at scrutiny. Vehicles which suffer damage must be re-examined before entering the track again.

7. TIMING

8. Passengers

Please note that Passengers must be attired to the same standard as Drivers and must have completed and signed the Passenger Indemnity Form.

9. EVENT FORMAT

Drivers Briefing.at 8:00
First time on track after 8:30. Sessions are planned for every 90minutes approximately of 12 minutes duration
Time permitting there may be a lunch break

10. FACILITIES

ARDC Café operating all day for hot food, coffee etc Fuel is available commercially in the fuel bay behind scrutineering

11. Noise

- 11.1. The maximum noise limit is 95db. measured at 30 metres.
- 11.2. Noise testing may take place at any time at the discretion of the Chief Scrutineer or the Clerk of Course. Any car found to exceed the maximum noise emission limit will be suspended from the Event until the Chief Scrutineer / Clerk of Course is satisfied that action has been taken to bring it within the limit. Any vehicle that exceeds the limit on two runs will be excluded from the remainder of the Event.

12. SMOKING

Smoking in the Pit, Paddock, buildings, roof area is prohibited.



13. DRUGS & ALCOHOL

Consumption of alcoholic liquor by Drivers or Pit Crew is forbidden prior to the completion of the Event in accordance with Schedule 3 of the NCR's. All Drivers must have a BAC below 0.01 and no illicit drugs in their system.

14. DRUGS & ALCOHOL TESTING

- 14.1. All Competitors and Officials are advised that random drug and alcohol testing may take place during the competition.
- 14.2. Any Driver or Crew Member being found to be under the influence of alcohol or recreational drugs during the Event will be excluded from the Event, and further penalties may be imposed in accordance with the NCR's.

15. FUEL

- 15.1. Fuel is available from Bowsers in the refueling bay.. Fuel can only be stored in 20 litre fuel drums or containers that meet AS1940/AS/NZS2906 or higher in order to comply with relevant State Regulations. There is a maximum of 2 x 20 litre containers per bay at any one time.
- 15.2. Refueling must take place outside of garages/carports. All Drivers, Crew, and Passengers must be outside of the vehicles while refueling. A Crew Member should be on stand-by holding a fire extinguisher during the refueling process for a hot vehicle.
